### **CUSA 2024 General Election Referendum Proclamation**

Having received notice of referendum questions, duly passed by Council on December 4, 2023 in accordance with sections 4(1)(a) and 6(1) of the Referenda and Recall Policy, the Chief Returning Officer gives notice to all electors that the five referendum questions listed below will appear on the ballot as part of the 2024 CUSA General Election.

#### **Campaign Period:**

Monday January 29, 2024 to Thursday February 8, 2024 - 5:00pm EST.

#### Voting Period:

Tuesday February 6, 2024 - 9:00am EST to Thursday February 8, 2024 - 5:00pm EST.

#### **Campaign Committee Meeting**

In accordance with S.14 of the Referenda and Recall Policy, the Chief Returning Officer gives notice that the Referendum Campaign Committee meeting will occur on Wednesday January 24 at 8:00PM EST on campus (exact location TBC).

All campaigning for the referendum must be conducted through one of the campaign committees. Those interested in campaigning must attend the campaign committee meeting and register themselves with the CRO.

#### **Referendum Questions:**

#### 1) Millennium Promise Fee

Millennium Promise currently collects \$3.00 from every Carleton student per semester as an external ancillary fee group. Do you support the removal of this ancillary fee paid by Carleton students?
