Indigenous peoples living under the modern colonial state of Canada have suffered disproportionate injustice and marginalization. A mere land acknowledgement is not enough to make reconciliation and reparation to the Indigenous peoples of Turtle Island. We must stand in solidarity against colonialism and remember our responsibility to the land and the peoples who have kept it for generations—which means affirming their call for the free and unencumbered return to their ancestral land. It is also fitting, for this body of lawmakers, to remember the spirit and wisdom of Indigenous governance models—from the collaborative bicameralism of the Haudenosaunee Confederacy to the consensus-based government of the Inuit—to deliver to students a better student union.

## Om Maradia – Vice President Finance/Treasurer

### 1. Key Priorities & Goals: Updates on Progress Toward Major Priorities

Financial Oversight & Transparency

We remain on track with regards to organizational wide spending as per November budget vs actuals and the mid-year report shared in the previous council meeting. Currently in the process of assessing budget vs actuals for December. Closely monitoring Admin, Building Operations department & Ollies.

Preparation of the budget 26/27 is in the works. Will be meeting with all the budget holders with potential changes/suggestions to each departmental budget. This will be a lengthy process which will take place in the month of February. We will set more realistic expectations for next year by monitoring and comparing monthly budget vs actuals reality for this year.



### Student Discount Card Expansion

We have now successfully onboarded 90 businesses across 110+ locations — a major milestone this year. I continue to monitor the program, manage inquiries, and collaborate with the Communications team, VPSL, and content creators to maintain strong visibility and outreach. No major updates since last report aside from managing inquiries/feedback from partners and content creation from Chonk Nation. We added a new business: La Crystal Nail Studio and had to remove Khokha Eatery (due to change in ownership).

### Generating Additional Revenue

I continue to work with the President, and Executive Director to lease underutilized CUSA spaces and create sustainable revenue streams. However, we are still in the process of identifying viable tenants. This remains a challenge, as it has been difficult to find organizations willing to lease space under current university constraints. Currently in contact with an interested party and will be meeting them on January 27th to discuss potential options.

## **2. Highlights & Wins: Notable Successes Since the Last Report**

Q1 and Q2 financials remain on track with total expenses amounting to \$1,882,190.24 (approx. 34% of the total budgeted expenses of the year) for the first six months in 25/26. The total budgeted expense for the year 25/26 is \$5,648,700.03. Reflects the dedication of every staff member in the organisation in terms of achieving financial stability. No major update since last report.

## **3. Challenges & Barriers: Key Issues and How They Are Being Addressed**

### Wing Space Vendor Access

External vendors interested in using the Wing space must go through a lengthy university approval process. Despite the space being managed by CUSA, vendors are often denied due to potential conflicts with the university's existing partnerships. The university committee responsible for approvals meets only once per month, so missed deadlines often delay progress by weeks. No major updates as we haven't been in contact lately due to other work commitments (this isn't a priority as of right now).

#### **(C-99) Motion to support CUPE 4600s Open Letter on Artificial Intelligence Guardrails at Carleton.**

**Whereas**, Teaching Assistants, Service Assistants, and internally-funded Research Assistants represented by CUPE 4600 play a critical role in delivering high-quality education, academic support, and research at Carleton University;

**Whereas**, CUPE 4600 Unit 1 has been in collective bargaining with Carleton University since September 2025 and has identified protections surrounding Artificial Intelligence (AI) as a core bargaining priority based on extensive member consultation;

**Whereas**, CUPE 4600 has repeatedly tabled proposals seeking basic guardrails on the use of AI in teaching, evaluation, data use, and labour practices, and Carleton University's bargaining team has refused to meaningfully engage with these proposals;

**Whereas**, Carleton University has indicated that its bargaining team lacks a mandate from the Board of Governors to establish AI-related protections

within the Collective Agreement, despite the absence of a finalized and binding institutional AI policy;

**Whereas**, the unchecked adoption of AI in higher education raises serious concerns regarding academic integrity, labour displacement, data privacy, intellectual property theft, algorithmic bias, environmental harm, and the erosion of critical thinking and pedagogical quality;

**Whereas**, students rely on human educators for meaningful feedback, mentorship, and academic development, and the replacement or degradation of this labour would undermine the quality of education students pay for and expect at Carleton University;

**Whereas**, CUPE 4600's demands do not restrict individual research or teaching about AI, but rather seek to protect education workers from coercion, surveillance, deskilling, and the involuntary use of AI tools that conflict with ethical, academic, or pedagogical principles;

**Whereas**, CUSA has a mandate to advocate for student interests, educational quality, and the fair treatment of workers whose labour directly shapes the student learning experience;

***Be It Resolved That,***

1. CUSA Council formally expresses its support for CUPE 4600 Unit 1 and its efforts to secure meaningful protections against the misuse of Artificial Intelligence in the working and learning environment at Carleton University;
2. CUSA Council endorses CUPE 4600's core demands, including:
  - no use of Generative AI in hiring, evaluation, or discipline decisions;
  - protection of education workers' data, intellectual property, and grading materials from AI systems;

- the right to refuse AI-related work that conflicts with ethical, academic, or pedagogical principles without reprisal;
- 3. CUSA calls on the Carleton University Board of Governors and senior administration to provide their bargaining team with a mandate to meaningfully engage with CUPE 4600's AI-related proposals in good faith;
- 4. CUSA recognizes that decisions about AI adoption in education must prioritize students, educators, and educational integrity, rather than cost-cutting, automation, or speculative technological promises;
- 5. CUSA commits to sharing [CUPE 4600's open letter](#) through its communication channels and encouraging students and campus groups to engage with and support education workers advocating for ethical and high-quality education;
- 6. CUSA affirms that technological innovation should enhance human education.

**(C-104) Motion to develop and upload a "Student Support Pathways" Graphic on the CUSA website**

**Whereas**, many undergraduate students experience difficulty navigating supports due to resources being scattered across many platforms

**Whereas**, many undergraduate students are not fully aware of CUSA, what it does, and what resources it offers. Many do not have a clear understanding of which resources are available or which representatives are responsible for specific concerns.

**Be it resolved**, that two graphics are created and published on the CUSA website. One graphic is to be dedicated for CUSA services: "Student Support Pathway - Services" and the other to the roles of members within CUSA: "Student Support Pathway - People"

## **(C-105) Motion to Condemn Systemic Oppression by the Iranian Regime and its Clerical Leadership**

**WHEREAS**, the Islamic Republic of Iran continues to systematically violate fundamental human rights, including freedoms of expression, religion, gender equality, bodily autonomy, academic freedom, and peaceful assembly;

**WHEREAS**, the clerical leadership of the Iranian regime has overseen ongoing acts of state violence, arbitrary imprisonment, and execution of dissidents, women, labour organizers, ethnic minorities, and LGBTQ+ individuals;

**WHEREAS**, CUSA stands in solidarity with LGBTQIA2S+ people and opposes discrimination based on sexual orientation or gender identity, while the Iranian regime continues to violently repress and criminalize queer and trans individuals;

**WHEREAS**, the Islamic Revolutionary Guard Corps (IRGC) functions as the primary instrument of internal repression, enforcing authoritarian rule and violent crackdowns on democratic movements such as Zan, Zendegi, Azadi ("Woman, Life, Freedom");

**WHEREAS**, CUSA recognizes that women and gender non-conforming people experience intersectional barriers, and the Iranian regime's gender-apartheid policies directly violate principles of equality and justice;

**WHEREAS**, Iranian workers, students, and ethnic communities (including Kurdish, Baloch, and Arab populations) have faced increased repression for advocating for self-determination and justice;

**WHEREAS**, CUSA is committed to dismantling racist systems and opposing systemic racism in all forms, and the Iranian state's persecution of ethnic minorities constitutes a form of state-sanctioned racism;

**WHEREAS**, the IRGC acts as a destabilizing force in the Middle East and funds systemic oppression globally;



**WHEREAS**, many Iranian, Middle Eastern, and international students at Carleton University have been personally affected by state violence and have called for the recognition of the Iranian regime's ongoing abuses;

**WHEREAS**, Iranian and Iranian-diaspora students at Carleton are experiencing heightened fear, grief, and psychological distress as a direct result of the IRGC's ongoing violence against civilians and students in Iran;

**WHEREAS**, CUSA rejects anti-immigrant rhetoric and supports migrants seeking refuge, while Iranian diaspora students in Ottawa may face intimidation or threats from the Iranian state and its proxies;

**BE IT RESOLVED**, that the Carleton University Students' Association (CUSA) unequivocally condemn the Islamic Republic of Iran as an authoritarian, clerical-militarized regime responsible for systematic violence, gender-based oppression, and the suppression of student-led liberation movements;

**BE IT FURTHER RESOLVED**, that CUSA explicitly denounce the IRGC as a central arm of state repression, responsible for widespread violations including enforced disappearances, torture, and the violent crushing of the "Woman, Life, Freedom" uprising;

**BE IT FURTHER RESOLVED** that CUSA, in collaboration with its relevant executive portfolios and advocacy departments, condemn the political persecution of dissidents who are denied fair trials and the right to defend themselves under the IRGC's practices;

**BE IT FURTHER RESOLVED** that CUSA reaffirm its solidarity with all individuals resisting the Iranian regime's authoritarianism, including students, women, queer communities, and ethnic minorities;

**BE IT FURTHER RESOLVED** that CUSA publicly commit to opposing the Iranian regime's efforts to silence or intimidate diaspora communities in Ottawa, and condemn any attempts by the Iranian state to export repression beyond its borders;

**BE IT FURTHER RESOLVED** that CUSA be mandated to collaborate with Persian students, feminist organizations, and human-rights groups at Carleton to raise awareness of the Iranian regime's ongoing abuses;

**BE IT FURTHER RESOLVED** that CUSA's international-solidarity programming explicitly include recognition of the Iranian people's struggle and uplift the voices of those fighting for freedom, dignity, and democratic liberation;
